1. Offer Description:

Eligible CBD Credit Cardholders can enjoy a complimentary standard valet parking service through **Valtrans and The Valet** service providers across select locations in the UAE. VIP Valet parking service is only applicable to select CBD Credit Cardholders.

Terms and Conditions:

- To avail the complimentary valet parking service, cardholder needs to make a minimum retail spend of AED 10,000 in a calendar month. Retail is defined as spends done at merchant point-of-sale terminals, online (E-Commerce) and excludes Balance Transfers, Cash on call, ATM cash advances, Interest and Fees charges.
- If the cardholder does not meet the minimum retail spend criteria for a calendar month in which the valet parking service is availed, shall be charged with the value of the benefit as mentioned in the table below.
- Spends done through CBD Mobile banking app or internet banking channel shall not count towards the achievement of retail spend criteria.
- Transaction date as opposed to posting date will be considered to check customer's eligibility of meeting the minimum retail spend criteria.
- Supplementary cardholders are not provided with any additional valet parking visits and are covered in the primary cardholder's per month complimentary visits eligibility with supplementary cardholders spends being added towards overall Primary Card eligibility.
- Any dispute with respect to what constitutes an eligible retail spend shall not be entertained.

CBD may change these Terms and Conditions at any time without notice. These Terms and Conditions are in addition to the standard CBD Credit Card Terms and Conditions

- These Terms and conditions are governed by the laws of UAE and subject to exclusive jurisdiction of Dubai Courts.

Frequently Asked Questions:

1. What is the Valet Parking offer?

Eligible CBD Credit cardholders can enjoy a complimentary valet parking service through Valtrans, and The Valet service providers across select locations in the UAE.

2. Are there any other conditions to avail this offer?

Yes, eligible credit card holders must have a minimum retail spend of AED 10,000 in the calendar month in which they wish to avail of the offer. Retail spend includes all transactions at point-of-sale terminal and E-Commerce transactions but excludes Balance Transfer, Cash-on-Call, and Interest & fees charges on the eligible cards.

3. What happens if the cardholder doesn't meet the minimum retail spend criteria or have exceeded number of complimentary visits in a calendar month?

If a cardholder does not meet the minimum retail spend criteria or has exceeded the maximum number of complimentary parking visits allowed in a calendar month, the cardholder credit card account shall be charged for the benefit value which was availed by the cardholder as per table below.

4. How does the cardholder avail of the offer?

Eligible cardholders need to simply show his/her CBD Credit Card to the respective valet parking attendant and sign on the form provided to avail the complimentary valet parking service. Valet service provider may charge a small fee on card holders credit card ranging between AED 1 to AED 2 at the time of availing the valet service. This fee is non-refundable and would be charged to cardholders' card upon availing the facility.

5. If the customer has two eligible primary CBD Credit Cards, can the valet parking benefit be availed on both cards?

Yes, subject to customer meeting the minimum calendar month retail spend criteria of AED 10,000 on both cards.

6. Is this facility available for supplementary cards as well?

Yes, it's available on eligible supplementary cards (refer Q2 above); however, the monthly usage cap is applicable across the primary and supplementary credit card combined.
